## NAPFA Members Launch Black & Latinx Intern Program

Chicago, IL – Members of the National Association of Personal Financial Advisors (NAPFA) have partnered to launch the BLatinX Internship Program (BLX) for the summer of 2021. Chloe Moore, Luis Rosa, Emlen Miles-Mattingly and Shawn Tydlaska – all fee-only advisors – developed the program to increase diversity and representation in the financial planning industry in the wake of George Floyd's death and in the spirit of the Black Lives Matter movement.

According to the CFP Board and the US Census Bureau, only 3.8% of certified financial planners (CFPs) are Black or Latinx, while these groups make up more than 31% of the demographics of the United States.

"Our goal is to place 100 interns, but we think we will have enough supply and demand to place 200," shared Shawn Tydlaska. So far, more than 20 firms across the country have committed to host a Black or Latinx intern for eight weeks this summer, including:
